DESCRIPTION

The Super Kits Enclosure SK128 is the world's only one which has > 100 compartments for enclosing SMT components, such as chip resistors, capacitors, inductors, diodes, triodes, LEDs, ICs, etc. See above Figures 1, 2, 3, 4 and 5.

The Super Kits Enclosure measures only 11"(L) \times 8.5"(W) (the letter paper size) \times 2.2"(H) (279mm(L) \times 216mm(W) \times 56mm(H)). Thus, they can be easily put on a work bench, stored on a shelf, or transported to another site, making them the best choice for building prototypes or reworking printed circuit boards.




Figure 7. Close-up Photo of the Coverlet Labels




Figure 8. Photo of the Big Top Label

See Figure 5 above, The Enclosure has 128 individually lidded compartments ((0. 63"(L) \times 0.89"(W) \times 0. 65"(D) or 16mm(L) \times 22.6mm(W) \times 16.5mm(D)). The lid of compartment using ergonomic design is very comfortable to operate. These compartments form a matrix of 8 rows \times 16 columns. A set of labels for the 128 coverlets comes with the enclosure. See below Figure 7. The coverlet label can be printed by the laser printer, or written by hand. We also provide two top labels and two front labels. See Figure 8 and 9 below respectively. If you need additional labels, you can purchase them from us. Their unit prices are shown in Table 4.

Using this enclosure will make your lab bench neat and your parts well organized. We have two types: SK128 and ASK128A, the former is for enclosing larger SMT components for the sizes of > 1206, the latter can store SMT components of as small as 0201. See below Table 1, 2 and 3.

APPLICATIONS INFORMATION

Operating the Enclosure is easy and convenient so that your time for obtaining a particular compartment is minimized.

To ensure proper operation, follow the steps described below carefully.

Firstly, please put the enclosure on a work bench, and then, open the top cover of the enclosure as shown in Figure 10 and the lid of the compartment as shown in Figure 11.

When storing or obtaining an SMT component, use a pair of tweezers as shown in Figure 12.

COMPARISON

The Super Kits Enclosure has two types: SK128and SK128A. They are not completely same. The SK128 doesn't leak large-size components, such as 1206 or larger, but would leak small size parts, and the SK128A doesn't leak both large-size and small-size components, even down to 0201. The SK128 is cheaper than the SK128A. The comparison of SK128 and SK128A Enclosures is shown in Table 1.
